







Fig. 1 - ESD Discharge Current Wave Form acc. IEC 61000-4-2 (330 Ω / 150 pF)




Fig. 2 - 8/20 µs Peak Pulse Current Wave Form acc. IEC 61000-4-5




Fig. 3 - 10/1000 µs Peak Pulse Current Wave Form




Fig. 4 - Typical Capacitance C_{D} vs. Reverse Voltage V_{R}




Fig. 5 - Typical Reverse Voltage V_R vs. Reverse Current I_R




Fig. 6 - Typical Peak Clamping Voltage V_C vs. Peak Pulse Current I_{PP}




Fig. 7 - Typical Peak Clamping Voltage V_{C-TLP} vs. Peak Pulse Current I_{TLP}






Fig. 8 - Typical Clamping Voltage V_{C-TLP} vs. Pulse Current I_{TLP}


